Residency Fees for Lighthouse Beach: \$50 Application per Individual, \$35 Criminal Background Only, \$400 Initial Registration/Seasonal Lot Hold, \$200 Transfer Fee. Please reference the application procedures below to see how these fees apply.

- 1. <u>\$50 Application fee for Credit & Background Check.</u> Non-Refundable MUST BE 21 YEARS OF AGE AND EMPLOYED TO BE A SIGNER ON A LICENSE AGREEMENT
 - **Married (different last names)** or with significant other \$50 per separate name.

 Each person with different last name needs a separate credit and background form completed to be a signer on the license agreement.
 - b. Married (same last names) \$100 includes both husband & wife credit and background check. Both husband and wife can be processed on the same application as applicant #1 & #2.
 - c. <u>All person(s) 18 years</u> or older residing at the RV site for more than one week in a given camping season must be listed on the application and license agreement and complete a background check form, **NO EXCEPTIONS.** There is a charge of \$35 for each additional criminal background check.
 - d. <u>Please refer to our Occupancy Rule #6, A licensee must be present at the site at all times.</u>

 Please be sure to consider this issue when completing your application, if you have questions please feel free to ask our office for assistance.

You must provide a copy of your last two paystubs with the completed application. If self-employed provide a copy of your previous year tax return. You must provide a copy of a valid driver's license.

<u>Note:</u> Names listed on the Title to the RV <u>MUST</u> be a signer on the license agreement. Copy of the Title is required for the file or copy of finance agreement if applicable.

Felony Convictions: Any applicant with a Felony Conviction within the past 7 years of their application will be denied residency in Lighthouse Beach RV Resort Campground.

The application process may take as much as three weeks to process. As soon as the results are received, we will contact you to inform you of the status and follow-up with a letter.

- 2. <u>\$400 Initial Registration / Seasonal Lot Deposit Fee</u> is required to reserve a seasonal RV site. We cannot hold more than one site per application. A site cannot be held without a lot hold deposit. Lot holds are only held for a max mum of 30 days from application approval.
 - **a.** Applicant has three (3) days from date of signing the application to cancel and receive a refund. After three (3) days of the signing of the application the Lot Hold Fee is only refundable if residency is denied by Mid Atlantic Shore Properties, Inc./t/a Lighthouse Beach RV Resort Campground.
 - b. A <u>\$400 Renewal Fee</u> is charged in <u>September of each year</u> for seasonal winter storage/lot hold deposit on seasonal RV sites.
- 3. Transfers —A transfer fee is required when an RV site transfers by sale or a current resident is moving from one site to another site in the resort campground. The Transfer Fee is \$200 and in the event of a sale of the RV the buyer pays the transfer fee at the time of the signing of their license agreement. In the case of a resident that is transferring sites within the campground, it may be necessary to complete a new application for residency. If the resident has been in residency more than two (2) years a new background and credit check is required. Current Residents with more than two rears in residency will be required to complete a new application for residency as stated below. Residents must have occupied their current seasonal site for at least one entire season and current on their seasonal rental payments and have no violations in order to be eligible for transfer to another site.

Important Note: The RV trailer cannot be moved to the new site until all the proper paperwork has been completed and the new license agreement signed. All sheds, decks, patio or other structures must meet current building codes and community standards to be transferred to the new site. The current site must be left in good condition and clear of any debris and left ready for a new occupant.

- 4. Purchasing a Seasonal RV in Lighthouse Beach RV Resortfollowing procedures must be completed:

 Before purchasing a unit in Lighthouse Beach the
 - **a.** Seller must give three (3) weeks written notice of their intention to sell the RV, including name of potential buyers if known before any applications will be accepted for a site.
 - b. Buyers must complete an Application for Residency, which includes a complete credit check and background check as outlined in item #1. Inspection of the RV and the site is required prior to completing the sale.

 Seller should NOT complete the sale of the RV until Lighthouse Beach Management has approved the potential buyers for residency.
 - c. Once applicant(s) have been approved for residency the seller can complete his sale of the RV trailer, the buyers can place their \$400 initial registration/lot hold for the seasonal site or deposit/hold of an amount equal to one month's rent for a year-round site and schedule a time with the management office to come in and complete the processing of the new License Agreement. A \$200 transfer fee is also required when RV ownership is changing to a new owner/resident and the RV will remain on our site.
 - 4. If there is any prepaid rent for the site, the Seller needs to determine how that rent is to be distributed.
 - 1. Refunded to seller, or
 - 2. To convey to buyer with transfer of the site.

Note: The R♥ site must be in clean condition and free of any violations in order to be transferred to the new buyer.

Insurance Requirements: Seasonal Site License Agreements cannot be executed without this coverage.

Please be adv sed that Lighthouse Beach requires every site to have General Liability Insurance against claims for bodily injury or death occurring upon, in or about the Lighthouse Beach RV Resort Campground to afford protection to the limit of not less than \$50,000 n respect to bodily injury or death to any one person to the limit of not less than \$100,000 in respect to any one accident.

Gate Cards: A \$10 fee per licensee is required for each gate card issued to a resident.

Please be advised that a maximum of four (4) people are permitted as signers on our Seasonal License Agreements.
